We are the **Baptist Union of Great Britain** ("BUGB", "we", "us"), a charitable incorporated organisation registered in England and Wales under charity number 1181392. Our contact details are:

This privacy notice describes what information (your 'personal data') we process about you through the use of our website <a href="https://www.baptist.org.uk">https://www.baptist.org.uk</a>, the purposes for which we collect it and how we will handle and use it.

For the purposes of data protection law, we are considered as the 'controller' of the personal data we collect and hold about you and we are therefore responsible for it.

Our Legal Services Manager (Damien Miller) is our **Data Protection Officer** and he is the person responsible for matters relating to the protection of personal data. He can be contacted at the address above or by email (dataprotection@baptist.org.uk) or phone 01235 517700.

We are registered with the Information Commissioner's Office ("ICO") with registration number Z5717589.

#### 1. INFORMATION ABOUT YOU

By using our website, we may collect the following information about you in the following ways:

## 1.1 Information which you give us

We collect information about you when you fill in forms on our website and when you communicate with us. This includes (but is not limited to) the information you provide us with when you sign up to one of our mailing lists, complete your Church Update, fill out one of our 'contact us' forms, respond to a survey, book into an event or purchase something from our online shop.

This can include your full name, address, email address, phone number, financial and credit card information, dietary preferences or access requirements.

You may also provide us with your photo or video footage containing your image. We will publish images on our website where we have your explicit consent to do so.

## 1.2 Information we collect about you

By visiting and interacting with our site we also collect certain information about you automatically. This includes information about the browser you use, the type of computer, your means of connection to our site, the operating system and the Internet service providers utilized and other similar information, as well as information about your visit. This may include the date and time of your visit, clickstream to, through and from the website, how much time you spend on each webpage and how you interact with the website.

For all images and video that we take as BUGB, we will ensure that all possible participants have a clear understanding of our processes and are able to give or withdraw their consent at any point to the retention and/or publication of their image(s) in line with our <a href="Image Sourcing and Permissions Policy">Image Sourcing and Permissions Policy</a>. Where images are provided to us by a third party, we will not publish these

or embed video footage on our website without confirmation in writing that the third party has the necessary rights and permissions from you to use and share your personal data in this way.

# 2. WHY WE COLLECT THIS INFORMATION

To enable you to book into events which we are running or promoting, to purchase a resource from our online shop, or to apply to be a part of the Networking Zone or a delegate at the Baptist Assembly.	This information is necessary to enable us to provide you with the requested event entry, purchase or booking. By providing us with the requested details you are giving your consent for this information to be processed for this specific purpose only. Where these events are live streamed please see the information below about our use of YouTube.

Responding to your queries, including prayer requests, through our 'contact us' section	This information is necessary for us to be able to reply to your query or request. By providing us with the requested details you are giving your consent for this information to be processed for this specific purpose only. If you are providing personal data for the purpose of prayer, you are giving your consent for this information to be processed for this specific purpose only.

## 4. WHERE WE KEEP YOUR PERSONAL DATA

All your personal information covered by this notice will be stored in the UK. To deliver services or manage our relationship with you, it is sometimes necessary for us to share your Personal Data outside of the UK (e.g. when our service providers are located outside of the UK). Many countries do not have the same data protection laws as the UK. We will, however, take reasonable steps to ensure that any such service provider has in place appropriate measures to protect your information and any contract includes appropriate clauses about the use of data. For instance, we will take steps to confirm that a third party outside of the UK is either covered by an existing adequacy agreement or has put in place regulator approved standard contractual clauses to provide an adequate level of protection for personal data.

## **MAILCHIMP**

Please note that our regular mailings are facilitated through 'MailChimp' which may process this data in the United States. 'MailChimp' processes data in compliance with the Standard Contractual Clauses approved by UK Data Protection Law in order to provide an adequate level of protection for personal data. You have the right to unsubscribe from such mailings at any time.

## **YOUTUBE**

We have no influence on the data transferred to YouTube. By visiting a website with embedded YouTube videos, a connection between your browser and the Google marketing platform may be established.

## 5. RETENTION OF DATA

## 6. YOUR RIGHTS IN RELATION TO YOUR DATA

You have a number of rights under data protection law. These include:

## 9. COOKIES

Like most other websites, our website uses cookies.

Cookies are small files which websites store on your computer and which contain various types of information about your visit to a website.
